Dear Representative,

On behalf of our millions of members and supporters, we are writing to urge you to oppose H.R. 8, the North American Energy Security and Infrastructure Act. This bill is an unprecedented assault on our nation's rivers and the people and wildlife that depend upon them. Its passage would end 95 years of balance in hydropower licensing, tipping the scales against taxpayers and in favor of huge utilities.

During consideration of H.R. 8, the House Energy and Commerce Committee adopted the McMorris Rodgers-McNerney Amendment. The amendment was developed in secret, with no input from recreation and conservation interests or the states, tribes, and federal natural resource agencies whose authorities will be usurped by FERC if the bill is enacted.

Two provisions of the McMorris Rodgers-McNerney Amendment are particularly troubling. First, H.R. 8 would allow power companies that operate hydroelectric dams to avoid compliance with the Endangered Species Act. If this amendment were to become law, it will be much more difficult to recover threatened and endangered populations of Pacific salmonids, shad, sturgeon, and Atlantic salmon, or any other aquatic species whose access to spawning habitat is blocked by power company dams. This amendment is a breathtaking assault on one of our nation's bedrock environmental laws.

Further, the McMorris Rodgers-McNerney Amendment would allow large utilities to ignore state and tribal requirements under the Clean Water Act that their dams meet water quality standards. This amendment appears to have been added to benefit a small number of huge corporate interests who are afraid that their dams, built many decades ago, might now have to comply with the Clean Water Act and meet the same water quality standards that other users of our waterways have been required to meet for years. For example, H.R. 8 could allow Exelon Corporation to avoid meeting its share of the responsibility to clean up the Chesapeake Bay, which is why Maryland's Republican administration has

opposed this provision. It could also allow Pacific Gas and Electric to get out of doing its part to meet water quality requirements on rivers that have been impaired by California's historic drought, which is why the State of California has also opposed this provision. If H.R. 8 is enacted, the burden for protecting these and other important bodies of water will fall disproportionately on other users of the river, particularly agricultural producers and municipalities.

Hydropower licenses are issued for up to 50 years. Hydropower facilities that are coming up for relicensing now were first constructed before virtually all modern environmental laws were in place. It is during relicensing proceedings that the public gets the opportunity to ensure that dam owners make the necessary changes to comply with modern laws. The opportunity to mitigate for the damage to the environment, while still providing reliable electricity, only arises once in a generation or two.

The balance the Federal Power Act strikes between power and non-power values has existed for almost a century. Current law protects the public's right to enjoy its rivers, a right which can and should be compatible with responsible electricity production. However, H.R. 8 upends that balance. Simply put, the McMorris Rodgers-McNerney Amendment is a massive giveaway to special interests at the expense of healthy rivers and the fish, wildlife, and people that depend upon them. If H.R. 8 passes, power company profits will go to the head of the line, ahead of every other user.

If you care about clean water, irrigation, meeting tribal treaty and trust obligations, wildlife, recreational fishing, commercial fishing, whitewater boating, water quality, municipal water supply, fire safety, flood control, or any other purpose other than generating power, then you should vote NO on H.R. 8.
